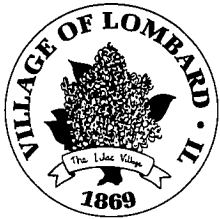

The State of Illinois awarded contract #PSD4015168 for Bituminous Mix for the FY 2009-2010. The successful bidder is DuKane Asphalt Company. Public Works contacted Matthew Dunteman requesting approval to purchase asphalt through DuKane Asphalt Co. from June 1, 2009 through December 31, 2009 under the terms and conditions of the State of Illinois contract. On May 5, 2009 I received confirmation allowing the Village to purchase asphalt through DuKane Asphalt Co.
