SUBJECT: Title XI, Chapter 112, Section 112.24(e) of the Lombard Village Code in regard to

Outdoor Seating and Service Area.

It has come to the attention of staff regarding the service and use of glass bottles and glassware for beverages served on a rooftop, of an establishment, to amend language and set parameters that would prohibit the service and use of glass bottles and glassware if the rooftop/outdoor seating and service area is situated within 10 feet (10') of the property line of the premises or public right-of-way.

Attached is an ordinance amending Lombard Village Code Title XI, Chapter 112, Section 112.24 in regard to the Outdoor Seating and Service Area.

(E) If the outdoor seating and service area on the licensed premises, as referenced in subsection (B) above, is other than on the ground floor of the licensed premises (i.e., on a rooftop or on an open air balcony or porch on a second or higher floor), it shall be unlawful to serve any beverages, including alcoholic beverages, in glass bottles or glassware, within the outdoor seating and service area.

The following includes the above as an amended under Section 112.24 "Additional Conditions of the License" Subsection (E) to read as:

(E) If the outdoor seating and service area on the licensed premises, as referenced in subsection (B) above, is other than on the ground floor of the licensed premises (i.e., on a rooftop or on an open air balcony or porch on a second or higher floor), and is situated within ten feet (10') of the property line of the licensed premises or a public right-of-way, such as a public sidewalk or street, it shall be unlawful to serve any beverages, including alcoholic beverages, in glass bottles or glassware, within the outdoor seating and service area.

AN ORDINANCE AMENDING SECTION 112.24 OF ARTICLE II OF CHAPTER 112 OF TITLE XI OF THE LOMBARD VILLAGE CODE IN REGARD TO OUTDOOR SEATING AND SERVICE AREAS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Article II, Section 112.24, Subsection (E) of the Lombard Village Code, is hereby amended, to read in its entirety as follows:

(E) If the outdoor seating and service area on the licensed premises, as referenced in subsection (B) above, is other than on the ground floor of the licensed premises (i.e., on a rooftop or on an open air balcony or porch on a second or higher floor), and is situated within ten feet (10') of the property line of the licensed premises or a public right-of-way, such as a public sidewalk or street, it shall be unlawful to serve any beverages, including alcoholic beverages, in glass bottles or glassware, within the outdoor seating and service area.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
