# AN ORDINANCE APPROVING TEXT AMENDMENTS TO THE LOMBARD SIGN ORDINANCE TITLE 15, CHAPTER 153 OF THE CODE OF LOMBARD, ILLINOIS

(Correction of a Scrivener's Error – Temporary Signs)

WHEREAS, the Village of Lombard maintains a Sign Ordinance which is found in Title 15, Chapter 153 of the Code of Lombard, Illinois; and

WHEREAS, the Board of Trustees adopted Ordinance 6834 on May 2, 2013 that intended to amend the Sign Ordinance to allow text or graphic symbols to be displayed on temporary inflatable signs and other attention-getting devices; and

WHEREAS, in further review of the adopted Ordinance, the Village finds that the Ordinance inadvertently failed to amend a table in Section 153.237 that prohibits text or graphics on inflatable signs and pennants; and

WHEREAS, the Village finds that this oversight was unintended and did not reflect the intent of the Plan Commission through its public hearing process and the Village Board in its approval; and

WHEREAS, the President and Board of Trustees find it appropriate and necessary to adopt an amended ordinance to reflect the intent of the Plan Commission and Village Board in its original approval of the text amendments.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

**SECTION 1:** That title 15, Chapter 153, Section 153.237, of the Code of Lombard, Illinois is hereby amended to read in part, as follows:

#### §153.237 TEMPORARY SIGNS.

(D) Permitted temporary signs by sign type and property type: Temporary Signs shall be allowed in the Village in accordance with the following table:

Sign Type	Multiple-Family Dwellings; on lots less than 1 acre in area, Attached Dwellings, Two- Family Dwellings, Detached Dwellings:	All other Areas
Pennants	P	P
Banners	N	P
Inflatable	N	P
Window	Y¹	Y
Feather	N	P

Page 2

Y = Allowed without sign permit.

P = Allowed only with sign permit.

N = Not allowed.

i = No commercial message allowed on sign, except for a commercial message drawing attention to an activity currently and legally offered on the premises.

SECTION 2: All other provisions associated with Ordinance 6834 not amended by this ordinance, or subsequently amended, shall remain in full force and effect.

**SECTION 3:** That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
