In response to your inquiry, please be advised that pursuant to the amendment to the Illinois Animal Control Act (510 ILCS 5/2.01 et seq.) made by Public Act 93-548, ordinances and regulations of Illinois municipalities which control dogs can no longer be "specific to breed." 510 ILCS 5/24. As such, enclosed please find the following Ordinance which brings the Village Code into compliance with the Illinois Animal Control Act:

Please note that this amendment to the Village Code in no way infringes upon the Village's ability to address vicious or dangerous dogs as defined by the Illinois Animal Control Act.
