In response to your inquiry, please be advised that pursuant to the amendment to the Illinois Animal Control Act (510 ILCS 5/2.01 *et seq.*) made by Public Act 93-548, ordinances and regulations of Illinois municipalities which control dogs can no longer be "specific to breed." 510 ILCS 5/24. As such, enclosed please find the following Ordinance which brings the Village Code into compliance with the Illinois Animal Control Act:

AN ORDINANCE AMENDING TITLE 9, CHAPTER 90, SECTION 90.04 OF THE
LOMBARD VILLAGE CODE IN REGARD TO ANIMAL CONTROL

Please note that this amendment to the Village Code in no way infringes upon the Village's ability to address vicious or dangerous dogs as defined by the Illinois Animal Control Act.

**AN ORDINANCE AMENDING TITLE 9, CHAPTER 90,
SECTION 90.04 OF THE LOMBARD VILLAGE CODE
IN REGARD TO ANIMAL CONTROL**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 9, Chapter 90, Section 90.04 of the Lombard Village Code is amended by deleting the words, "Pit Bulls", therefrom.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
