THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, TO APPEAR
ON THE BALLOT OF THE ELECTORS OF THE VILLAGE OF LOMBARD
AT THE GENERAL ELECTION TO BE HELD ON NOVEMBER 6, 2012

WHEREAS, the Village of Lombard is a municipal corporation duly organized and existing under the laws of the State of Illinois, and is a non-home rule unit of local government; and

WHEREAS, Section 28-7 of the Illinois Election Code (10 ILCS 5/28-7) provides that in any case in which Article VII of the Illinois Constitution authorizes any action to be taken by or with respect to any unit of local government, as defined in Section 1 of Article VII of the Illinois Constitution, by or subject to approval by referendum, any such public question shall be initiated in accordance with such Section 28-7, either by the governing body of the unit of local government by resolution, or by the filing with the clerk of the governmental unit a petition, signed by a number of qualified electors equal to or greater than eight percent (8%) of the total votes cast for candidates for governor in the preceding gubernatorial election, requesting the submission of the proposal for such action to the voters of the governmental unit at a regular election; and

WHEREAS, Section 7 of Article VII of the Illinois Constitution authorizes a municipality to provide, by referendum, for the municipality's officers, manner of selection and terms of office; and

WHEREAS, the President and Board of Trustees of the Village of Lombard have determined that it is in the best interests of the Village of Lombard that there shall be submitted to the qualified electors of the Village of Lombard a public question concerning whether to impose limitations on the terms of office of the Village's elected officials;

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

<u>Section 1.</u> That the proposition hereinafter set forth be submitted to the voters of the Village of Lombard (the "Village") at the General Election to be held on Tuesday, the 6th day of November, 2012, between the hours of 6:00 o'clock A.M. and 7:00 o'clock P.M. on said day (the "Election").

<u>Section 2.</u> That the Election shall be held in the voting precincts and at the polling places established by the DuPage Board of Election Commissioners (the "Election Board") for voters of the Village at the Election.

<u>Section 3.</u> That the Election Board shall give notice of the Election (the "Notice") by: (i) publishing the Notice once, not more than thirty (30) nor less than ten (10) days prior to the date of the Election, in a local, community newspaper having general circulation in the Village; and (ii) posting a copy of the Notice at least ten (10) days before the date of the Election at its principal office, as required by Section 12-5 of the Election Code of the State of Illinois, as amended (the "Election Code"), 10 ILCS 5/12-5.

Section 4. That the Village Clerk shall post a copy of the Notice at least ten (10) days before the date of the Election at the principal office of the Village.

<u>Section 5.</u> That the Notice published by the Election Board and the County Clerk, in a community newspaper having general circulation in the Village of Lombard, shall be in substantially the following form:

"NOTICE IS HEREBY GIVEN that, at the General Election to be held on Tuesday, the 6th day of November, 2012, the following proposition shall be submitted to the voters of the Village of Lombard, DuPage County, Illinois:

Shall the terms of office for those persons elected to the offices of Village President, Village Clerk or Trustee in the Village of Lombard, at the April 9, 2013 consolidated election and at each election for any of said offices thereafter, be limited such that no person so elected may serve more than three (3) consecutive full four (4) year terms in the same office?

The polls at said election will be open at 6:00 o'clock A.M. and will continue to be open until 7:00 o'clock P.M. of that day.

AT THE GENERAL ELECTION TO BE HELD ON NOVEMBER 6, 2012

As a result in a change in the law, the date in Section 8, by which the Village Clerk must certify the question to the DuPage Board of Election Commissioners, has been moved up by seven (7) days to August 30, 2012. As such, a certified copy of the Resolution must be filed with the DuPage Board of Election Commissioners on or before August 30, 2012.

In addition, the Resolution cannot be approved more than one (1) year prior to the election at which the referendum is to be held. As the referendum is scheduled for the November 6, 2012 general election, the Resolution cannot be adopted until at the November 17, 2011 Village Board meeting.

<u>Section 2.</u> That the Election shall be held in the voting precincts and at the polling places established by the DuPage Board of Election Commissioners (the "Election Board") for voters of the Village at the Election.

<u>Section 3.</u> That the Election Board shall give notice of the Election (the "Notice") by: (i) publishing the Notice once, not more than thirty (30) nor less than ten (10) days prior to the date of the Election, in a local, community newspaper having general circulation in the Village; and (ii) posting a copy of the Notice at least ten (10) days before the date of the Election at its principal office, as required by Section 12-5 of the Election Code of the State of Illinois, as amended (the "Election Code"), 10 ILCS 5/12-5.
