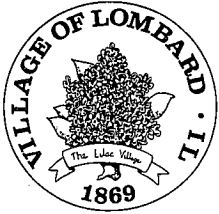

Subject: Fence Removal and Replacement at the Lombard Cemetery

---

On March 30, 2009 I met with two (2) fencing contractors at the Lombard Cemetery on Main Street. Then on Friday, April 3, 2009 I contacted a third contractor and faxed him the specs for the fence. I had given each of them the manufacturer, type and style of fence we were looking to have installed around the property. I asked each of them to submit a proposal for all work which included the replacement of the driveway gate, reinstallation of the existing Memorial Gate, installation of a new service gate on the west fence line and six (6) 18" X 18" X 5' high brick pillars to be located at each corner and on either side of the driveway gate. Their proposal should include the removal and disposal of existing fence.

I received quotes from the fence contractors and the results are as follows

Public works is requesting the Board of Trustees approve a waiver of bids and award of a contract to Action Fence Contractors, Inc., for an amount \$46,075.00 (pulling of posts with concrete above grade will be an additional cost and determined during demolition with both contractors) for the labor, materials and equipment to remove existing fence and install new Ameristar Echelon Plus Aluminum Ornamental Fence per proposal request. This work is to be completed by May 21, 2009 before the Memorial Day Rededication of the Cemetery
