130140 New Street at Hammerschmidt Avenue, Request to Remove No Left Turn Restriction

A resident request to remove the existing No Left Turn restriction. (DISTRICT #6)

Kalisik reviewed the item. To clarify, it is not a request to remove, but a request to modify the time. The reason it was originally installed was because of congestion when cars were queing for pick up for the school, drivers turning south onto Hammerschmidt from New created an issue with traffic coming north bound on Hammerschmidt.

Mr. Fitzgerald stated that the signage was installed without notifying residents. He would like for the sign to be changed to when children are present. It currently says School Days, but being senior citizens they don't always know when it's a school day. He went on to say that the chaos only exists for a 1/2-hour at 8:30 and 1/2-hour at 3, but residents are stuck all day trying to get out going to go south.

Larkin suggested that the time be changed from 8-9 AM and 3-4 PM. Chairperson Wilson pointed out that if it says when children are present then its subject to whenever a child is present, not just school days. Larkin added that it would have to say school days or it would be all summer too. Corso suggested that staff get feedback from the school.

A motion was made by Bob Corbino, seconded by John Larkin, Jr., that this Request be tabled. The motion passed by an unanimous vote.

130139 Lincoln Avenue at Ann Street, Request for a Stop Sign

A resident request to install a stop sign. (DISTRICT #2)

Kalisik reviewed the item. There is a lot of cut through traffic and it is an uncontrolled intersection. Legally, north bound must yield to Ann, but because Ann is a dead end to the west, drivers don't really look that way. Ms. Procopio explained that she has had many near misses as well as her neighbor. Mr. Procopio added that he would like some enforcement.

Chairperson Wilson directed staff to ask for a waiver of first reading for the Board submittal.
