Number of Public Passenger Licenses

Suburban Yellow Taxi LLC has applied for a taxicab license to operate a Taxi Company in the Village of Lombard. # **Company Rules**

Lease is due on Friday or Saturday, for each day lease is late driver will be charged \$10. If lease is a week late without notice to the owner, the car will be repossessed.

Driver will use the company square account for credit card processing.

Car will be repossessed if kept in poor condition, have 2 or more unpaid tickets.

All credit card transactions will incur a 5% fee.

Any Cash or check paid out after lease will be charged an additional 5% fee.

Driver must check all fluids before starting the day.

Driver must maintain cleanliness of vehicle.

Driver must allow car to run for five minutes before driving.

Driver is responsible for any ticket obtained while the car is in their possession.

The use of cell phones for personal use is prohibited unless in emergencies, for dispatch or credit card processing. Do not use cell phones while driving unless with a headset.

Driver shall assist customer with luggage as needed.

Driver shall not be disrespectful, use foul or indecent language to or in the presence of a customer.

The vehicle is not for personal use and any damage or expense that occur due to this use shall be the driver's responsibility.

Driver shall not smoke in vehicle or allow passengers to do so either. The taxi is considered a public place and state laws prohibit such actions.

I understand that picking up at any airport in Chicago without previous arrangement with the person(s) is illegal which will result in my arrest and the impounding of the vehicle. If this occurs, I am fully responsible financially and I understand I will be prosecuted to the full extent of the law.







## AN ORDINANCE AMENDING TITLE 11, CHAPTER 121, SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN REGARD TO PUBLIC PASSENGER LICENSES

# BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

(2) Number

Village Clerk

There shall be fourteen (14) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of granting a business license to Suburban Yellow Taxi LLC located at 216 Washington St., #1, Naperville, Illinois.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
