Mosquito Abatement Contract

On March 23, 2004 the Environmental Concerns Committee recommended approval of the attached contract with Clarke Environmental Mosquito Management, Inc. The Committee has put in a significant amount of study this year to improve our Mosquito Abatement Program. The Committee enlisted the aid of Sam Davis from the Illinois Department of Public Health, who attended meetings and gave advice by phone and email. The change in the contract is based on Sam Davis' suggestions.

The DuPage County Department of Health recently received a \$100,000 Federal grant for mosquito abatement. The County has agreed to install 4 Gravid traps in Lombard at no charge. These traps are specifically for the Culex Pipiens mosquito that carries West Nile Virus. The Village will also receive a New Jersey light trap and a CDC trap to track Aedes Vexans (nuisance mosquitoes) free of charge. As a result, the traps have been removed from the contract at a savings of \$31,000.

The Clarke contract is in the amount of \$81,606.50. This does not include any sprayings. If the Village were to authorize two community-wide sprayings, the cost would be about \$100,000, which is the amount in the budget. I recommend a waiver of bids and an award of a contract to Clarke Environmental Mosquito Management, Inc. in an amount not to exceed \$100,000 for the attached mosquito abatement contract for the 2004 season. Please note that due to my negotiations with Clarke, the contract will include the annual touch-up treatments at the Taste of Lombard at no additional cost.

- A. Targeted Mosquito Management System (TMMS) computer database and site management.
- B. Larval Site Monitoring:
 - 1. Three (3) complete inspections of up to 139 sites.
 - 2. Six (6) targeted inspections of up to 51 sites.
 - 3. Three (3) inspections of up to 38 historical Culex spp. sites
- C. Larval Control with *Bacillus thuringiensis israelensis (Bti)*, VectoLex CG (*bacillus sphraericus*) and stocking of mosquitofish (*Gambusia affinis*) for biological control at 1,000 to 1,500 per surface acre.
- D. Catch Basin Control: Four treatments of up to 4,296 street catch basins, inlets, and manholes with *Altosid® Briquets: \$11.00 season*
- E. Off Road Catch Basin Control: One (1) treatment of 221 off road catch basins with Altosid XR Briquets. Additional off road catch basins to be treated at \$10.00 per basin.
- F. Helicopter Application: Four (4) applications with 5% Abate pellets of 49 acres for larval control for sites found breeding *Culex spp*. (\$72.84/acre)

- A. Adulticiding in Residential Areas.
 - 1. Truck ULV treatments with Anvil® or synthetic pyrethroid insecticide at the direction of the Village. Village to be divided into 4 sections based on gravid trap locations. Treatments may be on a section or city basis at \$63.00 per mile (minimum 5 miles). Community wide treatments of \$8,820.00 per treatment.
- B. Adulticiding Operational Procedures
 - 1. Notification of community contact.
 - 2. Weather limit monitoring and compliance.
 - 3. Community resident notification.
 - 4. ULV particle size evaluation.
 - 5. Insecticide dosage and quality control analysis.
