

VILLAGE OF LOMBARD CONTRACT

CONTRACT DOCUMENT NUMBER SA 18 01

This agreement is made this 16th day of May 2024, between and shall be binding upon the Village of Lombard, an Illinois municipal corporation (hereinafter referred to as the "Village"), and Vortex Lining Systems LLC (hereinafter referred to as the "Contractor") and their respective successors.

Witnessed, that in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as set forth in the Contract Documents:

The rehabilitation of existing 90, 96, and 108 combination sewers by spray-on geopolymer method, the CIPP lining an existing 30-diameter RCP pipe, bypass pumping, sewer cleaning and televising, manhole lining, lateral service connections, sewer cleanouts, sewer point repairs, and traffic control protection in the contract amount of \$14,698,922.04

1. This contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:

 - xii) Notice To Labor Unions or Other Organizations of Workers Nondiscrimination in Employment
 - xiii) Certification Regarding Debarment, Suspension, and Other Responsibility Matters
 - xiv) Bidder Certification in Compliance with Article 33E-11 to the "Criminal Code of 2012
 - xv) Bidder Certification Regarding the Use of Iron, Steel, Manufactured Products, and Construction Materials produced in the United States (Build America, Buy America Act)
 - b. The Contractor's Bid Proposal Dated: May 7, 2024
 - c. Required Performance and Payment Bonds and Certificate(s) of Insurance
 - d. Village of Lombard Executed Bidder's Certification Form.
2. The Village agrees to pay, and the Contractor agrees to accept as full payment the amount as shown on the Contractor's Bid Proposal, which is made a part hereof, subject to such additions and deletions as agreed to by the parties hereto.

3. The Contractor shall commence work under this Contract upon written Notice to Proceed from the Village and shall complete work under this Contract within 270 calendar days from the date of the Notice to Proceed. Time is of the essence regarding this Contract, and the Contractor agrees to achieve completion within the time permitted by all proper and appropriate means including working overtime without additional compensation.
4. Under the provisions of Section 5 of the Mechanics' Lien Act of Illinois, before making any payment to the Contractor under this Contract, the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due each. This statement must be made under oath or be verified by affidavit. The Village shall not issue final payment nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
5. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.

IN WITNESS WHEREOF, the Village of Lombard, Illinois, and the Contractor have each hereunto caused this Contract to be executed by their respective duly authorized representatives this 16th day of May 2024.





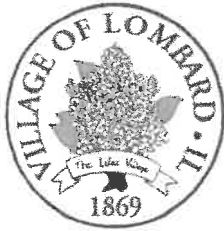
