

ORDINANCE NO. 6058

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

The east curb at the dead end of South Broadway east of School Street
The north turn-around at the dead end of South Broadway east of School Street

Section 2: That Schedule III of the Lombard Traffic Code (Ordinance 1186) entitled STOP INTERSECTIONS be amended to add the following thereto:

Pleasant Lane and Kramer Street

Section 3: That Schedule X (a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS be amended to add the following thereto:

| <u>Name of Street</u> | <u>From</u> | <u>To</u> |
|--------------------------------|---|--------------------------------------|
| Elizabeth Street Both sides | 200 feet north of the north curb line of St. Charles Rd. | South curb line of Windsor Avenue |

Section 4: That Schedule X (a) of the Lombard Traffic Code (Ordinance 1186) entitled PARKING TIME LIMITED ON CERTAIN STREETS be amended to delete the following therefrom:

| <u>Name of Street</u> | <u>From</u> | <u>To</u> |
|--------------------------------|---|------------------------------------|
| Elizabeth Street Both sides | 200 feet north of the north curb line of St. Charles Rd. | South curb line of Grove Street |

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.
