SUBJECT: 1 E. Roosevelt Road – Groundwater Restriction Ordinance (Rescind)

Attached is an Ordinance that would rescind Ordinance No. 7079 that was enacted on May 21, 2015 amending Title 5, Chapter 51, Section 51.02 of the Village Code to prohibit the installation or drilling of wells for potable and/or domestic water purposes within a modelled groundwater plume based on soil contamination at 1 E. Roosevelt Road. A separate and concurrent ordinance will replace the prior ordinance. The IEPA prefers enacting a new ordinance over amending the prior ordinance.

Staff recommends that the Ordinance be approved.
