## ORDINANCE

## AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B I" liquor license, contained therein, to read as follows, effective August 1, 2012

Class "A/B I" - 11

This increase in Class "A/B I" liquor licenses reflects the issuance of a Class "A/B I" liquor license to Patan, Inc. located at 801 E. Butterfield Rd., Lombard, who will be operating the business commonly known as Masala.
