Amendment #1 Design Services

Civiltech Engineering is under contract with the Village for the design of the Finley Road Pavement Rehabilitation project between Wilson Avenue and Glen Oak Road. Currently the first contract (Wilson Avenue to Charles Lane) is out for bid. Attached please find a contract amendment and resolution pertaining to the engineering services agreement for the next phase of the Finley Road Rehabilitation project (Charles Lane to Glen Oak Road).

Civiltech Engineering has submitted a cost estimate in the amount of \$39,328. This amount and the associated hours represent the effort required to split the project into two projects instead of the one project that was initially programed into the CIP.

During the preliminary engineering stage of the project, Village staff and the consultant evaluated the necessary improvements, estimated cost versus programmed costs and the feasibility of completing the job within the construction season under one contract. Each item was a factor that contributed to the decision to split the project into two separate construction contracts. The contract amendment provides for additional man-hours and corresponding fee to prepare another complete set of bid documents (Charles Lane to Glen Oak Road) and to account for hours necessary for coordination, associated meetings, and public involvement.

Please present this agreement and resolution to the President and Board of Trustees for review at their regular meeting of April 19, 2012. If approved, please have a copy of the resolution returned to Public Works-Engineering for further processing.

RESOLUTION R ___12

A RESOLUTION AUTHORIZING AN AMENDMENT TO A PROFESSIONAL SERVICES CONTRACT INVOLVING AN INCREASE/DECREASE IN THE DOLLAR AMOUNT OF THE CONTRACT OF \$10,000 OR MORE AND/OR EXTENDING/SHORTENING THE TIME IN WHICH THE CONTRACT IS TO BE COMPLETED BY THIRTY (30) DAYS OR MORE

WHEREAS, pursuant to Illinois Compiled Statutes, Chapter 720, Section 5/33E-9, units of local government are required to make specific findings prior to authorizing any amendment relative to a contract which would increase or decrease the dollar amount of the contract by \$10,000 or more, or would extend or shorten the time in which the contract is to be completed by thirty (30) days or more; and

WHEREAS, staff has presented and recommended the proposed amendment to the contract between the Village of Lombard and Civiltech Engineering Inc. regarding the Finley Road Pavement Rehabilitation project, as attached hereto as Exhibit "A" and made part hereof, (the "Amendment") to the Corporate Authorities of the Village of Lombard; and

WHEREAS, said Amendment attached hereto as Exhibit "A" would increase the dollar amount of the contract by \$39,328.00, with the revised total dollar amount being \$297,060.00

WHEREAS, said Amendment attached hereto as Exhibit "A" would extend the time period in which the contract is to be completed by 365 days;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That after reviewing the explanation of staff as to the necessity of and reasons for the Amendment attached hereto as Exhibit "A", the President and Board of Trustees find as follows:

- A That the circumstances which necessitated said Amendment were not reasonably foreseeable at the time the contract was entered into.
- B. That the basis of the Amendment was not within the contemplation of the contract when the contract was signed.
- C. That it is in the best interests of the Village of Lombard to approve the Amendment in its proposed form.
- D. That to the extent that it may have been necessary to go to bid relative to the work contemplated by said Amendment; bidding is hereby specifically waived as to the Amendment work.
