SUBJECT: Ordinance Amending Title 11, Chapter 112, Section 112.13 (A) of the Lombard

Village Code - The Cellar - 141 W. St. Charles Road, A

Uncork It LLC d/b/a The Vino Cellar currently holds a Class "L-I" liquor license. The primary purpose of the establishment is the sale of beer and wine only, by the glass, for consumption on the premises, in conjunction with the package sales of beer and wine only. Beer and wine tastings are also allowed, with or without a charge, and food may be provided to the patrons from restaurants that have entered into an agreement with the liquor licensee to delivery carry-out food to the licensed premises. The Village of Lombard has received notice that the current license holder, Uncork It LLC, will be assigning their lease to Wine Racks Enterprises, LLC, and will no longer be operating The Vino Cellar.

Concurrently, the Village of Lombard has received a request from Wine Racks Enterprises, LLC d/b/a The Cellar for a Class "L-I" liquor license to operate at the same location. Attached is an ordinance decreasing and increasing the number of Class "L-I" licenses by one to account for the new assignee.

Staff is requesting a waiver of first reading in order to accommodate the assignment of the lease.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "L-I" liquor license category, contained therein, to read as follows:

Class "L-I" - 0

This decrease in the number of Class "L-I" liquor licenses reflects the ceasing of business by Uncork It LLC d/b/a The Vino Cellar, and the termination of the Class "L-I" liquor license issued to The Vino Cellar in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "L-I" liquor license category, contained therein, to read as follows:

Class "L-I" - 1

This increase in the number of Class "L-I" liquor licenses reflects the issuance of a Class "L-I" liquor license to Wine Racks Enterprises, LLC, who will be operating the business commonly known as The Cellar, located at 141 W. St. Charles Road, A, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
