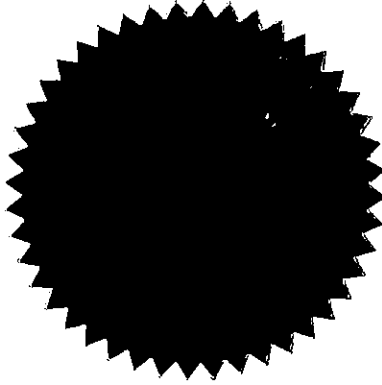

**ORDINANCE 5072**

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,  
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN**

**REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

**Section 1:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 7

This decrease in Class "A/B-II" liquor licenses reflects the closing of Annab's Crab House Inc. d/b/a Discovery Bay and the termination of the Class "A/B-II" liquor license issued to Annab's Crab House Inc. d/b/a Discovery Bay in relation thereto.

**Section 2:** That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 8

This increase in Class "A/B-II" liquor licenses reflects the issuance of a Class "A/B-II" liquor license to DJONT/EPT Leasing, L.L.C d/b/a Embassy Suites Hotel who will be operating the business commonly known as Discovery Bay, a Bar and Grill, 707 E. Butterfield Road, Lombard.

**Section 3:** This Ordinance shall be in full force and effect from and after its passage and approval as required by law.




