

NOTICE OF PUBLIC HEARING

The Village of Lombard Board of Trustees hereby provides notice that a public hearing will be conducted to consider the following petition:

The Village of Lombard requests three variations to provide relief from Chapter 151: "Flood Control" of the Lombard Code Of Ordinances, Subsection 151.55 "Retention/Detention Basins".

The petition is referred to as BOT 04-04. The property is located at 115 East St. Charles Road, Lombard, Illinois and is legally described as:

LOTS 1 THRU 5 IN BLOCK 17 IN THE ORIGINAL TOWN OF LOMBARD, TOGETHER WITH THE WEST ½ OF VACATED CHARLOTTE STREET, IN THE ORIGINAL TOWN OF LOMBARD BEING A SUBDIVISION IN SECTIONS 5, 6, 7, 8, AND 18 TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT THEREOF RECORDED AS DOCUMENT 9483 IN DUPAGE COUNTY, ILLINOIS.

LOTS 1 THRU 14 IN BLOCK 16 IN THE ORIGINAL TOWN OF LOMBARD, TOGETHER WITH THE EAST ½ OF VACATED CHARLOTTE STREET ON THE WEST AND EAST ½ OF VACATED MARTHA STREET ON THE EAST, IN THE ORIGINAL TOWN OF LOMBARD BEING A SUBDIVISION IN SECTIONS 5, 6, 7, 8 AND 18 TOWNSHIP 39 NORTH, RANGE 11 EAST OF THE THIRD PRINCIPAL MERIDIAN ACCORDING TO THE PLAT THEREOF RECORDED AS DOCUMENT 9483 IN DUPAGE COUNTY, ILLINOIS.
