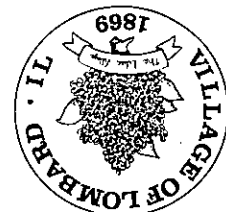
The attached ordinance decreases the number of Billiard/Pool Hall licenses from one (1) to zero (0).

SUBJECT: Amendment to Chapter 110, Section 110.08(E) of the Lombard Village Code in Regard to the Number of Billiard/Pool Hall Licenses.

As provided for by the ordinance governing the licensing of Billiard/Pool Halls, attached is an ordinance amending the number of approved Billiard/Pool Hall licenses.

The ordinance reduces the number of licenses from one (1) license to zero (0) licenses, to reflect the closing of Oscar's Billiards at 434 E North Avenue.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.08(E)
OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER
OF AUTHORIZED BILLIARD/POOL HALL LICENSES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DUPAGE COUNTY, ILLINOIS, as follows:

Section 1: That Title 11, Chapter 110, Section 110.08(E), of the Lombard Village Code is hereby amended to read as follows:

(E) There shall be not more than zero (0) billiard/pool hall licenses issued in the Village of Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
