**RESOLUTION ACCEPTING PUBLIC STREETS, WATERMAIN, FIRE  
HYDRANTS, STORM AND SANITARY SEWER AT YORKSHIRE WOODS  
(1700 BLOCK OF SOUTH NORBURY AVENUE, BRACKEN COURT,  
VENNARD COURT), IN LOMBARD, ILLINOIS**

WHEREAS, the Private Engineering Services Division of the Village of Lombard has certified the completion of the public streets, watermain, fire hydrants, storm and sanitary sewer at Yorkshire Woods (Bracken Court, Vennard Court, 1700 block of South Norbury Avenue), and has recommended that said improvements be accepted; and

WHEREAS, the Corporate Authorities concur with said recommendation.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the public streets, watermain, fire hydrants, storm and sanitary sewer at Yorkshire Woods (Bracken Court, Vennard Court, 1700 block of South Norbury Avenue), as certified by the Private Engineering Services Division and as set forth on the approved engineering plans, be and hereby are accepted for ownership by the Village of Lombard.

SECTION 2: That all storm sewer piping, structures and detention facilities on private property (i.e. not in the public right-of-way) are to remain the responsibility of the property owners and/or the owner's association.





**CERTIFICATE OF COMPLETION OF PUBLIC STREETS, WATERMAIN,

We recommend acceptance by the Village President and the Board of Trustees of the Village of Lombard.

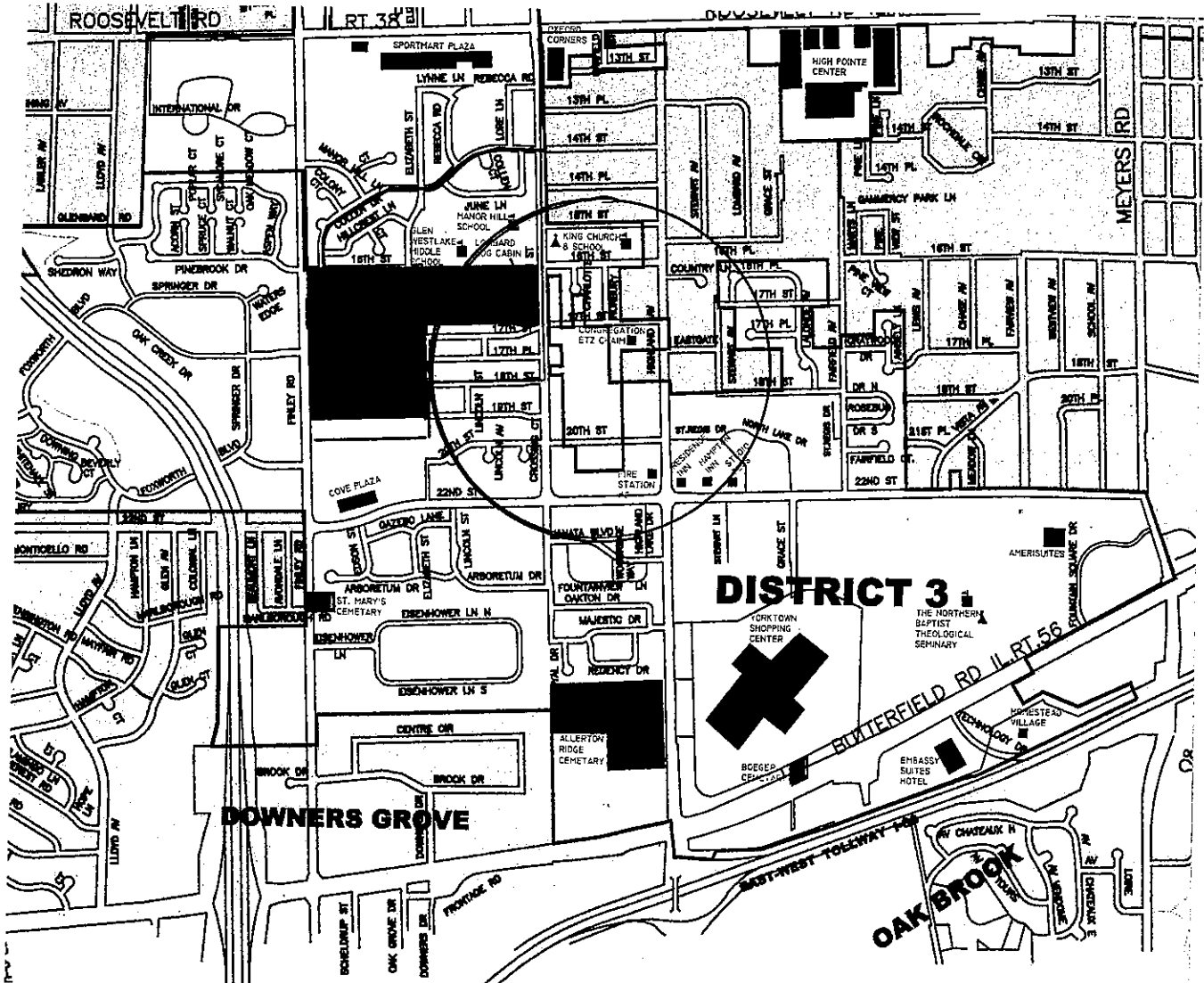
