**SUBJECT: TEMPORARY EVENTS CODE AMENDMENT**

As a companion to the other two ordinances relative to providing a new Class "P" overlay liquor license, attached is a draft ordinance amending Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code in regard to temporary events.

This amendment will provide for the ability to have more than four special event permits for a single parcel of property within the same calendar year if that entity holds a Class "P" liquor license for outdoor football events.

### **RECOMMENDATION**

Staff recommends that the Village Board approve an Ordinance Amending Title 11, Chapter 110, Section 110.47(B) of the Village Code in regard to Temporary Events.

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 110, SECTION 110.47(B) OF THE LOMBARD VILLAGE CODE IN REGARD TO TEMPORARY EVENTS**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That Title 11, Chapter 110, Section 110.47(B) of the Lombard Village Code is amended by adding the following language to the end thereof:

“In the case of an entity which holds a Class “P” liquor license, a single permit shall be issued each year, covering the entire Chicago Bears football season, relative to the events held pursuant to the Class “P” liquor license during said Chicago Bears football season.”

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
