On June 6, 2008, Bid Documents for the Village contract **PWO 0914**, *Tree and Stump Removal* were sent to 17 local tree care companies. The bid opening was held on June 20<sup>th</sup> with eight (8) bids being received. I have attached the Bid Tabulation sheet.

*Dawson's Tree Service, Inc.* had the lowest bid of \$23,130.00 which is \$1,870.00 under what has been budgeted this fiscal year for tree and stump removal. Although they have never been contracted by the Village in the past, *Dawson's* is an established, reputable tree company and I recommend awarding the contract to them.
