**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "P" overlay liquor license category, contained therein to read as follows:

Class "P" – 1

SECTION 2: That the change in the number of Class "P" overlay liquor licenses set forth in Section 1 above, is a result of granting an overlay liquor license to Miller's Ale House Inc. d/b/a Miller's Ale House Inc. located at 455 E. Butterfield Road, Lombard.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
