

ORDINANCE NO. 6048

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 12
OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

Section 1: That Title 11, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding the following thereto, to be inserted between the language therein relative to the Class “M” and Class “O” liquor licenses:

“Class “N” – Alcoholic beverages served in relation to food service, with the food service constituting at least forty percent (40%) of the gross income of the establishment. Package sales of wine and champagne only shall be allowed.”

Section 2: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein relative to the Class “N” liquor license to read in its entirety as follows:

“Class “N” - 1

This increase in the number of authorized Class “N” liquor licenses relates to the issuance of a new Class “N” liquor license to DOC West LLC d/b/a D.O.C. Wine Bar located at 326-328 Yorktown Center, Lombard, Illinois.

Section 3: That Title 11, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by revising the language therein relative to the Class “N” liquor license to read in its entirety as follows:

“Class “N” - \$1,500”

Section 4: That Title 11, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to “all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, O, R, T-I, T-II, X and Z liquor license holders,” to read, “all Class A/B-I, A/B-II, A/B-III, C, D, E-I, E-II, I, K, L, M, N, O, R, T-I, T-II, X and Z liquor license holders.”

Section 5: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.


