Subject: Replacement of block party wagon trailers and Public Works barricade trailers

---

The Lombard Park District and the Village of Lombard have a long-standing partnership providing residents the opportunity to host neighborhood block parties. This includes delivering trailers, “Block Party Wagons”, that are stocked with tables, chairs, grills and tents to be used for the block parties ahead of the event. These trailers are approaching 20 years old and are at the end of their useful life. The Park District and Village both want to continue this partnership and that will require replacing the trailers in order to supply the block parties with safe reliable Block Party Wagons. Request for proposals were requested of several local trailer dealers. A&W Auto Truck & Trailer of Darien, Il presented the lowest price for like trailer replacements at a cost of \$6,547 per unit. There are 6 trailers that need to be replaced for a total cost of \$39,282. These trailers will be purchased by the Village of Lombard and conveyed to the Lombard Park District via an IGA and bill of sale.

In addition to the purchase of 6 trailers for block party wagons, two public works trailers are included in the FY2024 budget to be replaced. These trailers store barricades to be deployed for large scale disaster event as well as at community events throughout the year. They are the same size and specifications as the block party trailers and will be funded from the vehicle reserve budget at a cost of \$13,094.

Staff recommends the Board of Trustees award a contract to A&W Truck & Trailer of Darien, Il in the amount of \$52,376 to purchase eight 6’x14’ Haul-About cargo trailers at the August 15, 2024 meeting.
