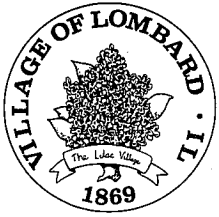

Subject: "No Parking" Morris Avenue, West of Main Street

Staff requests a change to the Village Traffic Code to post, "No Parking During School Hours" on Morris Avenue, west of Main Street. Eliminating parking during these hours will prevent access and littering issues that were occurring when high school students parked along this portion of Morris Avenue. This issue was brought forward by the residents that live along Morris Avenue, six of whom have signed the attached request (there are seven total residences).

These signs have been posted using Village emergency powers. Approximately 10 years ago, the Transportation and Safety Committee had directed staff to proceed ahead with these types of issues, without Committee review, and then take them to the Board to finalize the Traffic Code language. Along with the Committee's action on this particular item, Staff requests the Committee's guidance for acting on future requests/issues of a similar nature.

This item will be on the September 12, 2006 Transportation and Safety Committee agenda. The meeting is held at the Village Hall in the Community Room at 7:00 PM. This is a public meeting and public participation is encouraged.
