RE: Parkway Tree Trimming Contract Renewal

On October 4<sup>th</sup>, 2018, the Village of Lombard advertised for bids for the Village contract **PWO 19-15, Parkway Tree Pruning and Demand Trimming/Cabling**. The lowest responsible bid was received from D Ryan Tree and Landscape LLC. The original contract was from January 1, 2019 to December 31, 2019 with two optional one-year extensions. The final contract extension option would be from January 1, 2021 through December 31, 2021.

We have contacted D Ryan Tree and Landscape LLC and they have expressed interest in continuing the contract for the 2021 calendar year at the unit prices bid for the year three option. D Ryan Tree and Landscape LLC has provided good service to the Village. The FY21 budget contains \$65,000.00 from the Motor Fuel Tax fund for parkway tree trimming purposes.

Staff recommends renewing the Parkway Tree Trimming contract with D Ryan Tree and Landscape LLC for the amount of up to \$65,000.00. This is the second of two possible extensions of the contract and will expire December 31, 2021. Please present this item to the Board of Trustees at the January 21, 2021 meeting for their approval.
