Subject: **Waiver of Bids - Contract Extension FY 2022
Catch Basin Cleaning Project PWU-2134**

Background

On March 19, 2021, four bids were received for the Catch Basin Cleaning project. This project is designed to supplement the annual catch basin cleaning program performed by Village crews. The Village has a goal of cleaning one-third of the Village-owned catch basins each year. This program is one component of the Combined Sewer Overflow Operations & Maintenance Plan required by the IEPA Permit for the Lombard Combined Sewerage Treatment Plant to reduce sediment entering the treatment plant during rain storms. Bids were received from the following companies:

National Power Rodding	\$60,000
Greenline Environmental	\$104,000
Serenity Environmental Services	Non-responsive
United Septic, Inc., Bristol, IL	\$70,000
Budget	\$88,000

A contract was awarded to the lowest responsible bidder National Power Rodding, of Chicago, IL. They have performed satisfactory work for the FY 2021 contract and as well as in previous years for the Catch Basin Cleaning Projects.

National Power Rodding agreed to provide the same services under the same terms, conditions, and unit costs for one additional year. Funding is provided in the Water/Sewer Capital Reserve Fund RM PROG 12 Catch Basin Cleaning. The budgeted amount for FY 2022 is \$91,000.

Recommendations:

Please request the Board of Trustees to award a contract extension for the Catch Basin Cleaning Project to National Power Rodding, of Chicago, IL in an amount not to exceed \$60,000 for FY 2022 at their January 6, 2022 meeting.
