Last Call Operating Co II., Inc. d/b/a Champps Americana located at 2301 S. Fountain Square Drive currently holds an "A/B-III" liquor license. Staff received a letter dated September 1, 2016 from Last Call Operating Co II., Inc. advising that at the close of business on August 27, 2016 they officially and permanently closed. As a result, attached is an ordinance decreasing the Class "A/B-III" liquor license category by one as required by Village Code.

Staff is requesting a waiver of first reading in order to bring the number of licenses available in the "A/B-III" liquor classification current to reflect this change.

ORDINANCE _____

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-III" liquor licenses contained therein, to read as follows:

Class "A/B-III" - 14

Section 2: That the decrease in the number of Class "A/B-III" liquor licenses set forth in Section 1 above, is a result of Last Call Operating Co II., Inc. d/b/a Champps Americana no longer conducting business at 2301 S. Fountain Square Drive.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
