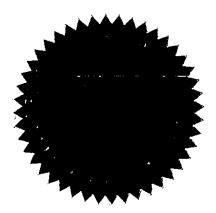

ORDINANCE 5326

AN ORDINANCE AMENDING ORDINANCE NUMBER 4538, ADOPTED SEPTEMBER 3, 1998, GRANTING A CONDITIONAL USE FOR A PLANNED DEVELOPMENT AND CONDITIONAL USE APPROVAL FOR A HOTEL IN THE O OFFICE DISTRICT

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Lombard Village Code; and,

WHEREAS, the subject property is zoned O PD Office District – Planned Development; and,

WHEREAS, an application has been filed requesting the amendment of the Corporate Centre at Heron Point Planned Development, adopted on September 3, 1998, as Ordinance Number 4538, in order to include an indoor swimming pool and spa at the hotel building; and,

WHEREAS, the application also requests conditional use approval for a hotel facility, and an expansion to the hotel facility, and,

WHEREAS, a public hearing on such application for a Planned Development amendment has been conducted by the Village of Lombard Plan Commission on June 16, 2003, pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the Planned Development amendment described herein; and,

WHEREAS, the President and Board of Trustees of the Village of Lombard have reviewed the request and find it would be in the best interest of the Village to grant said approval subject to the terms and conditions established by this Ordinance, and in accordance with the findings and recommendations of the Plan Commission which are incorporated herein by reference.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That an amendment to the conditional use for the Heron Point Planned Development is hereby granted, subject to the provisions noted in Section 3 below; and

<u>SECTION 2:</u> That a conditional use to allow for an expansion to a hotel facility in an O Office District is hereby granted, subject to the provisions noted in Section 3 below; and

<u>SECTION 3</u>: That Section 5, Item A of the Corporate Centre at Heron Point Planned Development (Ordinance 4538) is hereby amended to read in entirety as follows:

- A. The property shall be developed in substantial compliance with the Site Development Plan, prepared by W-T Engineering, dated April 25, 2003, subject to the following conditions:
 - 1. That the petitioner shall satisfactorily address the comments noted within the IDRC report.
 - 2. That the site shall be developed and operated consistent with Village Code.
 - 3. The proposed pool addition shall not encroach into an existing watermain easement and all hydrants shall be located at least five feet away from the building foundation.

<u>SECTION 4:</u> That all other provisions of Ordinance 4538 not amended by this Ordinance shall remain in full force and effect.

<u>SECTION 5</u>: That this ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
