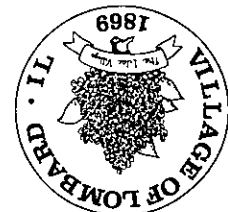

ORDINANCE

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village
Code is amended by revising the entry relative to the Class "G" liquor license, contained
therein, to read as follows:

Class "G" - 1

This decrease in Class "G" liquor licenses reflects the termination of American Drug
Stores, Inc. d/b/a Osco Drug and the termination of the Class "G" liquor license issued to
American Drug Stores, Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village
Code is amended by revising the entry relative to the Class "G" liquor license, contained
therein, to read as follows:

Class "G" - 2

This increase in Class "G" liquor licenses reflects the issuance of a Class "G" liquor
license to American Drug Stores, LLC who is operating the business commonly known as
Osco Drug located at 1177 S. Main Street, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its
passage and approval as required by law.
