BACKGROUND/POLICY IMPLICATIONS:

As directed by the Village Board at their meeting on January 19, 2006, the attached resolution has been prepared declaring the Village Board's commitment to use a portion of the 1% Non-Home Rules Sales tax, if approved by referendum on March 21, 2006, to freeze the capital rate portion of the water sewer rate, for the period of June 1, 2006 through May 31, 2007 at a rate of \$1.56 per 1000 gallons of water used, and to reduce the capital rate portion of the water and sewer rate, for the period of June 1, 2007 through May 31, 2016, to \$1.20 per thousand gallons of water used.

**A RESOLUTION DECLARING THE VILLAGE BOARD'S  
COMMITMENT TO USE THE ONE PERCENT (1%)  
NON-HOME RULE SALES TAX,  
IF APPROVED BY REFERENDUM ON  
MARCH 21, 2006, TO REDUCE THE CAPITAL  
RATE PORTION OF THE WATER AND SEWER RATES**

WHEREAS, the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, (hereinafter the "Village Board") are, subject to the requirement of prior referendum approval, authorized to impose a non-home sales tax in the amount of one percent (1%); and

WHEREAS, the Village Board has determined that a portion of the revenue received from any such one percent (1%) non-home rule sales tax should be used to reduce water and sewer rates to residents and businesses;

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, that if the one percent (1%) non-home rule sales tax is approved by referendum on March 21, 2006, the Village Board is committed to using a portion of said one percent (1%) non-home rule sales tax to freeze the capital rate portion of the water and sewer rates, for the period of June 1, 2006 through May 31, 2007, at a rate of \$1.56 per 1,000 gallons of water used, and to reduce the capital rate portion of the water and sewer rate, for the period of June 1, 2007 through May 31, 2016, to \$1.20 per 1,000 gallons of water used.
