Tree and Stump Removal Contract Renewal

The Village of Lombard opened bids for the tree and stump removal contract on February 22, 2013. The lowest responsible bidder was received from Ciosek Tree Service, Inc. The original contract was from March 7, 2013 to December 31, 2013 with an option to extend the contract from January 1, 2014 through December 31, 2014.

We have contacted Ciosek Tree Service, Inc. and they have agreed to maintain their prices from the 2013 contract for the 2014 calendar year. Ciosek Tree Service, Inc. has provided good service to the Village. The FY14 budget contains \$50,000.00 from Hotel/Motel and \$60,000.00 from CIP (Parkway Ash Removal and Replacement Program) for this service.

Staff recommends renewing the Tree and Stump Removal contract with Ciosek Tree Service, Inc. in an amount not to exceed \$110,000.00. This is the final extension of the contract and will expire December 31, 2014. Please present this item to the Board of Trustees at the December 19, 2013 meeting for their approval.
