FY12b New Vehicle Purchase, ALS Ambulance

The FY12b budget includes replacement of unit number FM64, a 2005 Ford F350 ALS ambulance. The last ambulance we purchased (delivered 12/10/10) took 9 months to build so I wanted to order the one approved for FY12b as soon as possible. As you know we want to standardize our fleet (with Horton ambulances) so we can start to re-chassis these in the future. We currently have five ambulances, four of them are Horton and the one we are replacing is a Road Rescue. At this point I think the only acceptable ambulance to us would be one manufactured by Horton therefore this purchase qualifies as a sole vendor situation and a bid waiver would be in order.

Public Works received a proposal from Horton Emergency Vehicles of Illinois for one new ALS ambulance per our specifications. The price for the new ambulance is \$161,450. In comparison, our last ambulance purchased 3/9/10 using competitive bidding resulted in a final price of \$153,429. An itemized list is attached detailing the price increases since our last purchase. These increases are also summarized below;

\$2,420	Horton base price increase 5/10
\$1,593	Horton base price increase 2/11
\$585	HVAC module interface (needed for new chassis)
\$655	Ford chassis increase
\$2,768	Lombard specified options (mainly LED lighting upgrades)
\$8,021	«Total

The budgeted amount for the new ambulance is \$160,000 which makes this purchase \$1,450 over budget. This shortfall will be made up by savings from other FY12b vehicle purchases.

I recommend the BOT waive bid and award of a contract to Horton Emergency Vehicles of Manteno, IL in the amount of \$161,450 for one new ALS ambulance. Please submit this item to the Village Board for their consideration at the December 1, 2011 meeting.
