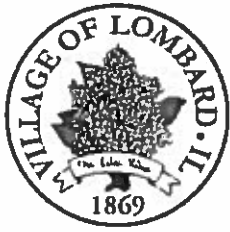

BACKGROUND

The Tri-Town YMCA has recently submitted an application to place banners advertising their annual **Healthy Kids Day**. The YMCA is requesting approval of the use of public right-of-way for temporary banner signs. The specific location of the sign would be the southeast corner of Main Street and Wilson Avenue

The sign would be approximately 24 square feet in area. The sign would be placed at the specified location on or around April 17, 2014 and would be removed on or about May 9, 2014.

RECOMMENDATION

Staff recommends that the Village Board grant the Tri-Town YMCA authority to use the public right-of-way for temporary signage for their **Healthy Kids Day**.
