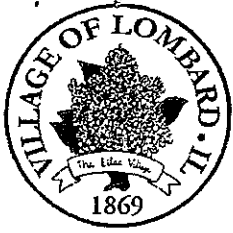

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.36
OF THE LOMBARD VILLAGE CODE IN REGARD TO
ALCOHOLIC BEVERAGES AND THE HOURS OF SERVICE**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.36 of the Lombard Village Code is amended by revising the references therein to "10:00 a.m." to read, "9:00 a.m."

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
