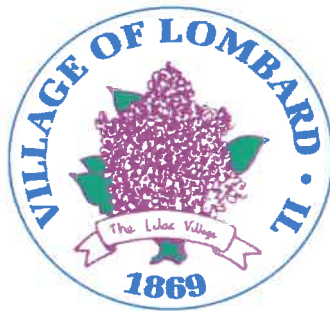

ORDINANCE NO. 8161

**AN ORDINANCE ESTABLISHING TITLE IX, CHAPTER 97, SECTION 97.010(D)
OF THE LOMBARD VILLAGE CODE**

(Mailbox Cluster Box Units)

WHEREAS, the Lombard Public Works and Environmental Concerns Committee met on May 9, 2023, to consider the Village Code amendments pertaining to establishing regulations pertaining to the placement and installation of Mailbox Cluster Box Units (CBU), where required by the United States Postal Service; and,

WHEREAS, the Lombard Public Works and Environmental Concerns Committee has filed their recommendations with the President and Village Board of Trustees, recommending approval of the Village Code amendments set forth below pertaining to CBU's; and

WHEREAS, the President and Board of Trustees approve and adopt the recommendation of the Lombard Public Works and Environmental Concerns Committee and incorporate such recommendations herein by reference as if they were fully set forth herein.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Title IX, Chapter 97, Section 97.010(D) of the Lombard Village Code is hereby established to read as follows:

D) Mailbox Cluster Box Units

In locations in which the United States Postal Service requires the installation of Cluster Box Units (CBU) to serve residential or commercial properties, the design and installation shall conform to the provisions of the United States Postal Service National Delivery Planning Standards Guide for Builders and Developers.

SECTION 2: That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.


