ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 110,
SECTION 110.21 OF THE LOMBARD VILLAGE CODE IN
REGARD TO COIN-OPERATED AMUSEMENT DEVICES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 110, Section 110.21 (C) of the Lombard Village Code is amended by revising the entry relative to Class A contained therein to read as follows:

Class A
Four (4) to eight (8) coin-operated amusement devices
No more than ten (10) licenses.

Section 2: That the change in the number of Class A licenses set forth in Section 1 above, is a result of granting a license to King’s Hall Corporation doing business as King’s Hall located at 1000-40 Rohlwing Road, Lombard.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
