ORDINANCE NO. 7226

**AN ORDINANCE REGULATING TRAFFIC IN THE VILLAGE OF LOMBARD
IN REGARD TO PLEASANT LANE**

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Public Safety and Transportation Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VI entitled "ONE-WAY STREETS" of the Lombard Traffic Code (Ordinance 1186) is amended to modify the following restrictions:

"Berkshire Ave., from Main St. to Charlotte St. Between 8:00 a.m. to 4:00 p.m. on school days, East direction of travel" to "Berkshire Ave from Main St to Garfield St between 8:00 a.m. to 4:00 p.m. on school days, East direction of travel."

"Pleasant Lane from Charlotte to Main Street, West direction of travel" to "Pleasant Ln from Garfield St to Main St between 8:00 a.m. to 4:00 p.m. on days on school days, West direction of travel."

Section 2: That this Ordinance shall be in full force and effect from and after its passage, approval, publication in pamphlet form and the posting of appropriate signs as provided by law.






