**SUBJECT: Request for a Class "C" Liquor License

The Village has received a request for a Class "C" liquor license from Lombard BBQ Inc. d/b/a Firewater BBQ N Brew located at 440 E. Roosevelt Road to serve beer and wine. Firewater BBQ N Brew received their Certificate of Occupancy/Zoning Certificate to operate as a Restaurant in the B4APD Zoning District on June 25, 2014 as has been operating as a restaurant since that time.

Attached is an ordinance increasing the Class "C" liquor license category by one and issuing a liquor license to Lombard BBQ Inc. d/b/a Firewater BBQ N Brew effective June 1, 2017.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That, effective June 1, 2017, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor license, contained therein, to read as follows:

Class "C" - 10

This increase in Class "C" liquor licenses reflects the issuance of a Class "C" liquor license to Lombard BBQ Inc. who will be operating the business commonly known as d/b/a Firewater BBQ N Brew located at 440 E. Roosevelt Road, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
