Renewal of the "Landscape Restoration Contract"

On May 15, 2008, the Village Board approved a contract with The TLC Group, Ltd., for the Landscape Restoration Contract. In the bid documents was a provision to extend the contract for an additional year. Attached is a letter from The TLC Group, Ltd., indicating their willingness to provide the same service, terms, conditions and unit pricing for an additional year.
