Please place this item on the September 3, 2020 Board of Trustees agenda for consideration.

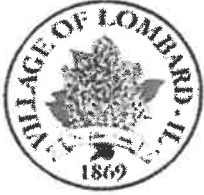

SUBJECT: Title XI, Chapter 112, Section 112.13(A) – Alcoholic Beverages
Marquette Kitchen & Tap - 18 W. St. Charles Road

The Village has been notified that Marquette Kitchen & Tap located at 18 W. St. Charles Road has permanently ceased business operations. In that regard, Village staff reached out to the managers/members of Chicago Tavern Group, LLC – Lombard who confirmed the same.

Village Code Title XI, Chapter 112, Section 112.27 states:

“In the event a licensee ceases to do business at the licensed premises, other than temporarily for a period of not to exceed 45 successive days, for purposes of remodeling, or for purposes other than remodeling but with the prior written approval of the Local Liquor Control Commissioner, the number of authorized licenses in the particular class shall automatically be reduced by one at the time the licensee ceases to do business.”

Attached is an ordinance decreasing the number of entries in the Class “A/B II” liquor license category by one.

Staff requests a waiver of first reading in order to bring the number of entries in the Class “A/B-II” liquor license category current.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license, contained therein, to read as follows:

Class "A/B-II" - 6

Section 2: That the decrease in the number of Class "A/B-II" liquor licenses set forth in Section 1 above, is a result of Chicago Tavern Group, LLC-Lombard d/b/a Marquette Kitchen & Tap located at 18 W. St. Charles Road, Lombard no longer conducting business.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
