DISCONNECTION OF A PORTION OF THE CHURCHILL

WOODS FOREST PRESERVE DISTRICT PROPERTY

FROM THE VILLAGE OF LOMBARD

The DuPage County Forest Preserve District owns and maintains a 49.78 acre property located at 889 E. St. Charles Road (parcel identification number 05-12-202-032) and at the far western end of the Village of Lombard's existing corporate limits. The subject property is improved with an historic structure (the McKee House) as well as a fleet maintenance facility for the District. The McKee House is currently the subject of a coordinated preservation effort by and between the non-profit McKee House Coalition. the Village of Glen Ellyn and the District. The Village of Lombard's Historic Preservation Commission has taken an informal role in the monitoring of this preservation effort.

The Village of Glen Ellyn has sought to have the corporate jurisdiction of the subject property changed from Lombard and Glen Ellyn, as they have been working with the District on long-term use of the aforementioned vehicle maintenance facility as well as facilitating many of the preservation efforts. The municipalities recognize that the intergovernmental boundary agreement (IGA) and their subsequent amendments contemplated the subject property to transfer jurisdictions from Lombard to Glen Ellyn. To that end, Glen Ellyn provided Lombard with a formal request and authorized by the District as property owner, to disconnect the property from Lombard, with eventual annexation to Glen Ellyn.

Attached is an Ordinance prepared by Lombard Village Counsel which will disconnect (de-annex) the subject property and the adjacent St. Charles Road right of way, located west of the previously established boundary line, as set forth within the previously established and amended IGA. Should the Ordinance by approved by Lombard, the Village of Glen Ellyn will proceed to annex the property. Said annexation is slated to be considered by Glen Ellyn at their June 25 Village Board meeting.

ACTION REQUESTED

Please place this item on the May 3, 2018 Village Board agenda for consideration and approval. Staff recommends approval of the attached Ordinance consenting to the Disconnection of the DuPage County Forest Preserve District Property at 889 E. St. Charles Road by the Village of Lombard.

ORDINANCE NO.

AN ORDINANCE DISCONNECTING CERTAIN PROPERTY FROM THE VILLAGE OF LOMBARD (A Portion of the Churchill Woods Forest Preserve Located West of I-355 and South of St. Charles Road, Along with that Portion of St. Charles Road Located North of and Adjacent Thereto)

WHEREAS, the provisions of 65 ILCS 5/7-3-4 and 5/7-3-5 grant the Village of Lombard (the "Village") the right to disconnect territory that is within the corporate limits of the Village, and is on the boarder of said corporate limits, upon receipt of a written petition to do so, signed by the owners of record of a majority of the area of the land within said territory; and

WHEREAS, that certain property, commonly known as A Portion of the Churchill Woods Forest Preserve Located West of I-355 and South of St. Charles Road and legally described in Exhibit 1 attached hereto and made part hereof (the "Subject Property") is located within the corporate limits of the Village, but is on the border of said corporate limits; and

WHEREAS, a Petition for Disconnection, a copy of which is attached hereto as Exhibit 2 and made part hereof, has been submitted to the Village, relative to the Subject Property, pursuant to 65 ILCS 5/7-3-4 and 5/7-3-5; and

WHEREAS, a Plat of Disconnection for the Subject Property, a copy of which is attached hereto as <u>Exhibit 3</u> and made part hereof, has been submitted to the Village and found to be acceptable; and

WHEREAS, the statutory provisions of 65 ILCS 5/7-3-4 and 5/7-3-5, as amended, for the disconnection of territory from the Village, have been fully complied with; and

WHEREAS, it is in the best interests of the Village that the Subject Property be disconnected from the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That the recitals, as set forth above, are hereby incorporated herein by reference and made part hereof.

SECTION 2: That the Subject Property, and that portion of the dedicated St. Charles Road right-of-way, located North of and adjacent to the Subject Property, as depicted and described on Exhibit 4 attached hereto and made part hereof, is hereby disconnected from the Village of Lombard, pursuant to 65 ILCS 5/7-3-4 and 5/7-3-5.

SECTION 3: That the Village Clerk is hereby directed to record with the Recorder of Deeds of DuPage County, Illinois, and to file with the County Clerk of DuPage County, Illinois:

- A. A copy of this Ordinance, certified by the Village Clerk; and
- B. A plat of the disconnected territory, said plat to be attached to the aforesaid certified copy of this Ordinance (Exhibit 3);

within ninety (90) days of the adoption of this Ordinance.

SECTION 4: That the Village Clerk is hereby directed to notify the election authority having jurisdiction in the territory hereby disconnected, and the post office branch serving the territory hereby disconnected, of said disconnection, by certified mail, return receipt requested, within thirty (30) days of the adoption of this Ordinance.

SECTION 5: That the various provisions of this Ordinance are to be considered severable, and if any part or portion of this Ordinance shall be held invalid by any court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.

SECTION 6: That all Ordinances or parts of Ordinances in conflict or which are inconsistent with this Ordinance shall e repealed to the extent of any such conflict or inconsistency.

SECTION 7: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.

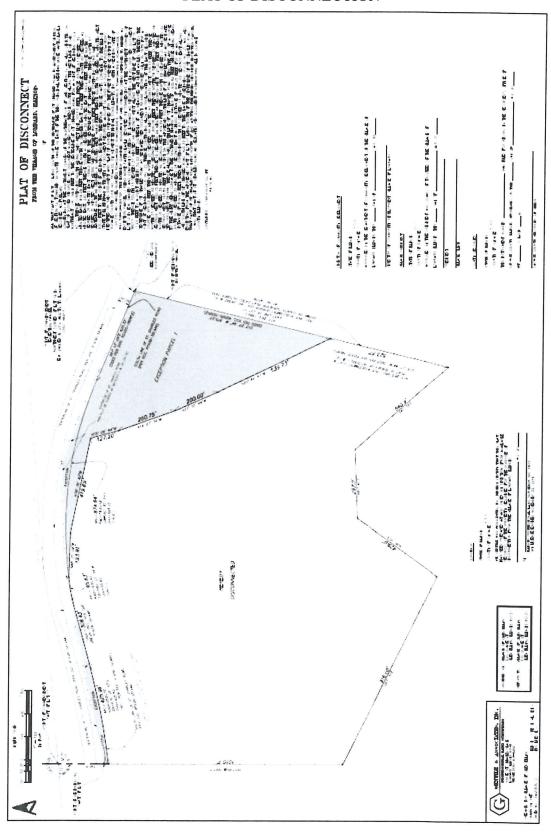
