The FY 2005 budget includes replacement of WM 493, a 2001 Ford E-150 Cargo Van.

In February, Public Works advertised and sent out competitive bid packets for the purchase of a 2005 Cargo Van. No bids were received. Rather than advertising again, Public Works sent requests for sealed proposals based on the actual bid document to an expanded number of dealers. Public Works received only one sealed proposal. The proposal was from Northwest Ford and Sterling in Franklin Park, Illinois. The total bid price for the 2005 Cargo Van is \$16,909 less a trade-in allowance of \$6,600 equals a total bid of \$10,309. The budgeted amount is \$17,000.

I recommend waiver of bids and award of a contract to Northwest Ford and Sterling in Franklin Park, IL. in an amount not to exceed \$10,309. I also recommend declaring WM 493 as surplus per the attached ordinance and authorizing its trade-in. Waiver of first reading is requested on this ordinance. Please submit this item to the Village Board for their consideration at the April 7, 2005 meeting.
