ORDINANCE _____

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112,
SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein to read as follows:

Class "U" - 1

This decrease in Class "U" liquor licenses reflects the change in ownership of Sushi Inn Japanese Restaurant Inc. d/b/a Sushi Inn Japanese Restaurant located at 719 E. Roosevelt Road, Lombard and the termination of the Class "U" liquor license issued to said licensee in relation thereto.

SECTION 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license, contained therein to read as follows:

Class "U" - 2

This increase in Class "U" liquor licenses reflects the issuance of Class "U" liquor license to True Star Inc. d/b/a Rokki Japanese Cuisine located at 719 E. Roosevelt Road, Lombard.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
