Public Works received five sealed bids. Packey Webb Ford was low bidder. The bid price for three (3) 4x4 pick-up trucks is \$84,745 less a trade-in allowance of \$36,600 equals a net bid price of \$48,145. The budgeted amount for these vehicles is \$58,500.

I recommend the B.O.T. award a contract to Packey Webb Ford of Downers Grove (IL) in the amount of \$48,145 for three (3) new 4x4 pick-up trucks with plows. I also recommend declaring Village units WT440, SM445, and SM446 as surplus per the attached ordinance and authorizing their trade-in. Waiver of first reading is requested on this ordinance.
