ORDINANCE NO.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112 OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 112, Section 112.36 of the Lombard Village Code is amended by adding a new subsection (E) thereto, effective upon the adoption of this Ordinance through 6:01 a.m. on Monday, October 1, 2012, which shall read in its entirety as follows:

"(E) In light of the fact that the Westin Lombard Yorktown Center Hotel is providing the accommodations for the players, the players' families, and other individuals involved in the 2012 Ryder Cup golf tournament at Medinah Country Club, and the fact that Westin Hotel Management L.P. d/b/a Westin Lombard Yorktown Center and H.C. Management Lombard, LLC d/b/a Harry Caray's Restaurant, which is located in the Westin Lombard Yorktown Center Hotel, will be hosting the after-tournament festivities on Sunday, September 30, 2012, for many of the individuals staying at the Westin Lombard Yorktown Center Hotel, with said aftertournament festivities expected to go beyond 1:00 a.m. on Monday, October 1, 2012, the hours of operation limitation, as set forth in subsection (A) above, shall be extended for Westin Hotel Management L.P. d/b/a Westin Lombard Yorktown Center and H.C. Management Lombard, LLC d/b/a Harry Caray's Restaurant, on Monday, October 1, 2012 only, so as to allow the sale, offering for sale and giving away of alcoholic liquor by Westin Hotel Management L.P. d/b/a Westin Lombard Yorktown Center and H.C. Management Lombard, LLC d/b/a Harry Caray's Restaurant, between the hours of 1:00 a.m. and 6:00 a.m. on Monday, October 1, 2012."

SECTION 2: That, effective at 6:01 a.m. on Monday, October 1, 2012, Title 11, Chapter 112, Section 112.36(E) of the Lombard Village Code, as set forth in Section 1 above, is hereby repealed, without need for any further action by the President and Board of Trustees.
