For the price of \$185,000.00 the Contractor will pressure wash all (6) six precast buildings on the Village complex. Then Contractor will remove all caulking and replace as described in the bid documents followed by rinsing off all dirt created by grinding from the buildings.

4.	This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.
5.	Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.
