#### 090569 Storm Water/Combined Sewer Modeling Project

Jeff Julkowski and Jeana Gowin from Christopher B. Burke Engineering, LTD in attendance to make presentation to committee members. Tross: did you have gauges out on the Sept. 2008 storm? Julkowski: yes we did at 2 locations. The presentation continued. During the presentation discussion ensued between Julkowski and committee members. Dratnol: keep in mind that this is just the first step in the process. This is just the interim fix. The final fix will involve sending all of this out to the DuPage River. Kaforski: this really needs to be monitored before we can even accept it as an interim fix. Julkowski continued with the presentation. Tross questioned the use of the 10 year storm as the model for the separation plans. Julkowski reviewed the cost estimates by Phases and also Ultimate Outfall. Kaforski: could the \$9.9 M be done in phases and only cost a certain amount per year? We wouldn't see the benefit of this until it was completed. Further discussion ensued. Tross: still taking one part of town and draining it into another part of town. Presentation and discussion continued. Tross: we still have the issue of combined sewer separation/surcharging and flooding in basements.

Kaforski: I am not for the interim thing. Dratnol: we can take water out of the combined system. Kaforski: I do not want to waste that money and I would rather see us start the work on the Prairie Path pipe solution. Dratnol: would like to see us have something now that we can at least get some relief from. Kaforski: I just don't think this is really going to help us much. I would like to see the monitors in place and see what happens. That data is critical. Further discussion took place. Kaforski: any further information regarding Villa Park pumping water into our pond? Goldsmith: there has been no further discussion with them.

Kaforski: would like to see additional monitoring at various locations. Staff will discuss with the Consultant and bring plan with additional monitoring and what it will cost to the October meeting.
