ORDINANCE NO. 4660

AN ORDINANCE AMENDING A CONDITIONAL USE PURSUANT TO TITLE 15, CHAPTER 155, SECTION 414.C OF THE LOMBARD ZONING ORDINANCE AND GRANTING A VARIATION PURSUANT TO TITLE 15, CHAPTER 153, SECTION 505.B.15

(PC 99-20: 225 E. Roosevelt Road, Lombard, Illinois) (Walgreens)

(Also see PC 98-31 Ordinance Nos. 4557, 4558, 4559, 4560)

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, the subject property is zoned B3 Community Shopping District; and,

WHEREAS, on November 5, 1998, the President and Board of Trustees adopted Ordinance 4558, granting conditional use approval to allow a drive-through facility on the property described in Section 4 below; and,

WHEREAS, an application has been filed requesting an amendment to said conditional use approval to allow a variation to increase the permitted number of wall signs facing Highland Avenue from one (1) to two (2); and,

WHEREAS, a public hearing on such application has been conducted by the Village of Lombard Plan Commission on June 21, 1999, pursuant to appropriate and legal notice; and,

WHEREAS, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the conditional use amendment and variation described herein; and,

WHEREAS, the President and Board of Trustees approve and adopt the findings and recommendations of the Plan Commission and incorporate such findings and recommendations herein by reference as if they were fully set forth herein;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That Section 4 of Ordinance 4558 is hereby renumbered as Section 5.

SECTION 2: That Section 3 of Ordinance 4558 is hereby renumbered as Section 4 and amended to add a ninth condition as follows:

9. That the total square footage for signage on the west elevation be no greater than one hundred (100) square feet.

SECTION 3: That Ordinance 4558 is hereby amended to add a new Section 3 as follows:

SECTION 3: That variations are hereby granted for the property described in Section 2 above and pursuant to Title 15, Chapter 153, Section 505.B.15 of the Lombard Sign Ordinance to increase the number of wall signs facing Highland Avenue from one (1) to two (2).

<u>SECTION 4</u>: That this ordinance is limited and restricted to the property generally located at 225 E. Roosevelt Road, Lombard, Illinois, and legally described as follows:

Lots 1, 2, 3 in Walton's Subdivision of part of the east half of the northwest quarter of Section 20, Township 39 North, Range 11, East of the Third Principal Meridian, according to the Plat thereof recorded November 9, 1979 as Document R79-101654, in DuPage County, Illinois.

SECTION 5: This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
